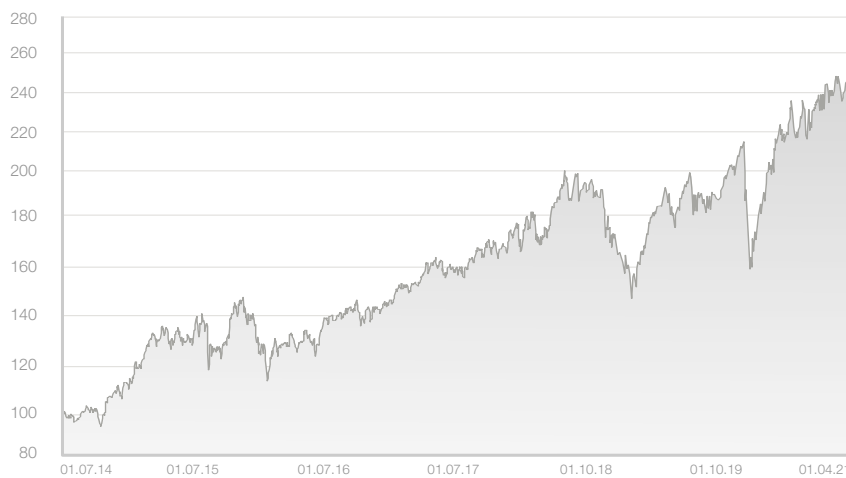


ECOMMERCE FUND FACT SHEET

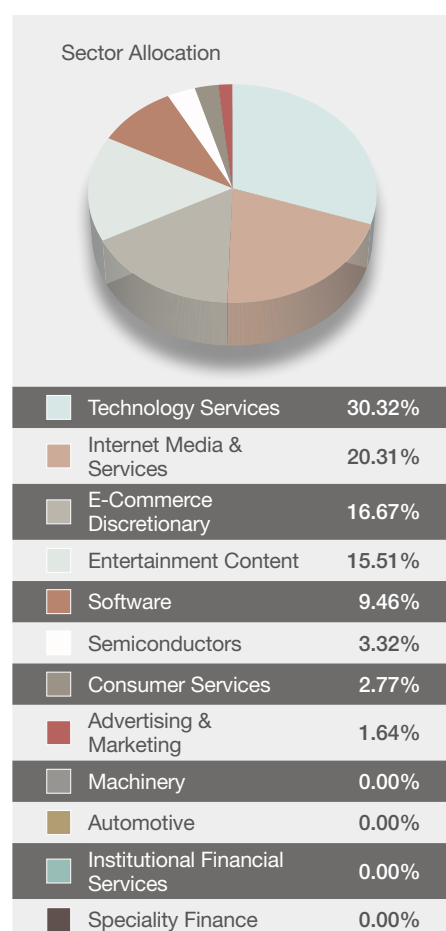
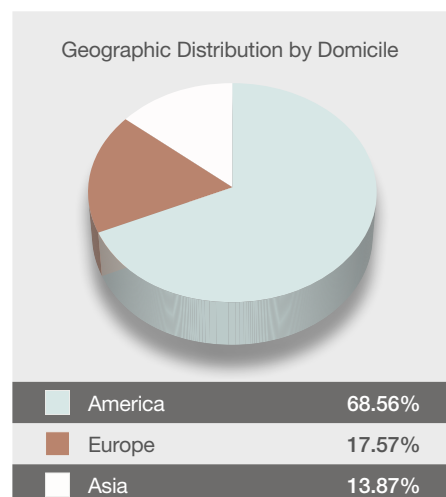
