This document provides you with key investor information about the Dominion Global Trends – Ecommerce Fund (“Ecommerce Fund”).

It is not marketing material. The information is required by law to help you to understand the nature and risks of investing in this Sub-Fund. You are advised to read it so you can make an informed decision about whether to invest.

Ecommerce USD IH Class – (ISIN: MT7000014668). This Sub-Fund is self-managed.

Objectives and Investment Policy

The Investment Objective of the Ecommerce Fund is to achieve medium to long term capital appreciation. The Ecommerce Fund will seek to achieve this investment objective primarily through investment in a diversified portfolio of securities issued by companies with operations that engage in innovative and technologically advanced commercial transactions (ecommerce). In particular, the Ecommerce Fund will seek to invest in those companies that are directly or indirectly involved in the retailing or provision of goods and services through electronic and digital means.

The securities used within the portfolio may include companies producing goods and services with a significant dependence or exposure to ecommerce. Examples of the sectors that may be used for investment purposes are as follows: Financial Services, General Retailers, Industrial Engineering, Industrial Transportation, Leisure Goods, Media, Personal Goods, Software & Computer Services, Support Services, Technology Hardware & Equipment, Travel & Leisure (please be advised that this list is non-exhaustive and may change over time).

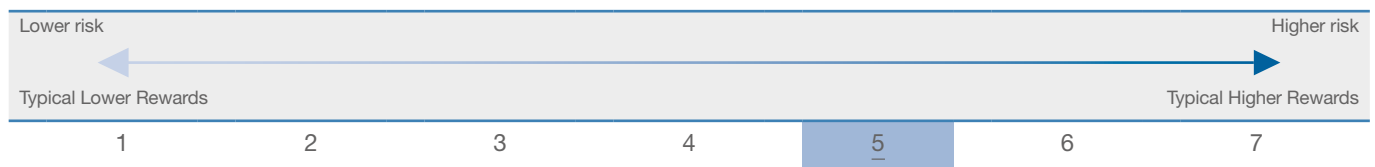
Up to 80% of the portfolio will be invested in companies with a market value in excess of €1 billion. The remainder of the portfolio may be invested in companies with a market value of less than €1 billion or that are about to become listed on recognised stock markets. The maximum for those companies not yet listed is 10% of the portfolio.

Ecommerce Fund may also use financial derivative instruments (financial instruments where the value is linked to the expected future price movements of the underlying assets) to protect the value of Ecommerce Fund's assets. This is limited to a maximum of 10% of the total value of Ecommerce Fund at any time. Ecommerce Fund may also invest in other assets, such as cash (or near cash instruments) or debt securities.

The income in respect of shares in the Ecommerce Fund is not distributed but is retained.

You can buy and sell the shares on any business day in Malta.

Risk and Reward Profile



The above risk and reward indicator rates this Share Class as category 5 meaning that it offers a relatively higher risk of making a loss but also a relatively higher chance of making gains. It should be noted that even the lowest category on the indicator does not mean risk free.

It cannot be guaranteed that investments in the Ecommerce Sector will generate continued growth in the future. It is also possible that the Fund may not be able to identify sufficient high-quality investment opportunities.

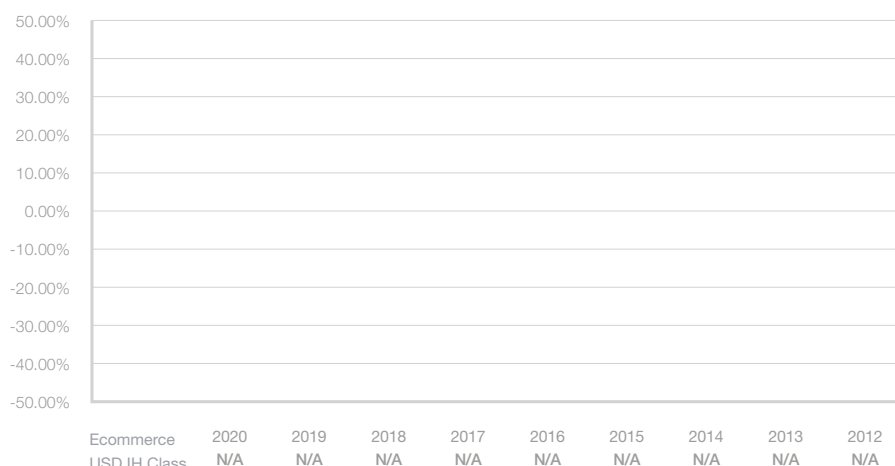
